### 1. WHAT ARE COOKIES?

Cookies are small text files placed on your device (computer, smartphone, or tablet) when you visit our Website. Cookies help us recognize your device, remember your preferences, ensure security, and provide you with a better browsing experience.

### 2. WHY WE USE COOKIES

We use cookies for the following purposes:

- Website Functionality: Enable essential features and secure access to protected areas
- Security: Detect and prevent malicious activity and protect your data
- Performance: Understand how visitors use our Website to improve functionality
- Personalization: Remember your preferences and settings

- Analytics: Collect anonymous statistics about Website usage

### 3. TYPES OF COOKIES WE USE

We categorize cookies into the following types:

#### 3.1 Strictly Necessary Cookies

Purpose: Essential for the Website to function properly. These cookies enable core features such as security, authentication, and session management.

Consent Required: No – these cookies are necessary for the Website to operate.

Duration: Session and persistent cookies.

#### 3.2 Functional Cookies

Purpose: Remember your choices and preferences (such as language, region, or login details) to provide enhanced, personalized features.

Consent Required: Yes.

Duration: Persistent cookies.

#### 3.3 Analytics and Performance Cookies

Purpose: Collect information about how you use our Website, including which pages you visit and any errors you encounter. This helps us improve Website performance.

Consent Required: Yes.

Duration: Persistent cookies.

#### 3.4 Marketing and Advertising Cookies

Purpose: Track your browsing activity to deliver relevant advertisements and measure advertising campaign effectiveness.

Consent Required: Yes.

Duration: Persistent cookies.

#### 4. THIRD-PARTY COOKIES

Some cookies are placed by third-party service providers that we use to enhance Website functionality and analyze usage. These third parties may include analytics providers, advertising networks, and social media platforms. We do not control these third-party cookies. We recommend reviewing their privacy policies to understand how they process your data.

#### 5. HOW WE OBTAIN YOUR CONSENT

When you first visit our Website, a cookie consent banner will appear. You can choose to:

- Accept All Cookies: Allow all cookie categories
- Reject Non-Essential Cookies: Allow only strictly necessary cookies
- Manage Preferences: Choose which cookie categories to accept or reject

We do not use pre-checked boxes, and non-essential cookies will not be placed on your device until you provide explicit consent.

#### 6. HOW TO MANAGE OR DELETE COOKIES

You have the right to accept, reject, or manage cookies at any time:

##### 6.1 Through Our Cookie Settings

You can change your cookie preferences by accessing our Cookie Settings tool available on the Website.

##### 6.2 Through Your Browser

Most web browsers allow you to control cookies through their settings. You can set your browser to refuse cookies or delete existing cookies. Please note that disabling necessary cookies may affect Website functionality.

- Session Cookies: Deleted when you close your browser

- Consent Records: Retained for a minimum of 5 years

## 9. INTERNATIONAL DATA TRANSFERS

If cookie data is transferred outside the European Economic Area (EEA) or United Kingdom, we ensure appropriate safeguards are in place, including Standard Contractual Clauses or other legally compliant transfer mechanisms.

## 10. UPDATES TO THIS POLICY

We may update this Cookie Policy from time to time to reflect changes in our practices, technology, legal requirements, or other operational needs. When we make material changes, we will:

- Update the "Last Updated" date at the top of this Policy

- Notify you through a prominent notice on the Website
- Request renewed consent where required by law
